### Calling for Expressions of Interest

This is the call to OGBs who would like to nominate themselves or recommend others to join the Managing Committee of the Global OGB Association (GO).

#### **Election of Management Committee**

- In accordance with the Constitution of the GO Committee, the term of office for Anirban Bhattacharyya, Alfred Khan, Nannette Gomez and Sushil Marda ends in October 2024
- All four current Members are eligible for re-election and have indicated they will be renominating
- Garth Mitchell, has recently relocated from the UAE and leaves a vacancy in that region

#### **Calling for Nominations**

Under the Constitution and Rules of the Association, individual OGBs who are registered GO Members as at 31 July 2024, may nominate as a candidate on the GO Managing Committee. Please note, this year the Committee has brought forward the election by one-month to align with the 10<sup>th</sup> Anniversary celebrations in September 2024.

We, once again, invite expressions of interest (EOI) from any GO Member to nominate to join the Worldwide Managing Committee of GO. The Association's Constitution allows for up to fifteen (15) Members on the Committee. Committee currently stands at eleven (11) Members.

The Committee is seeking to fill a number of vacancies this year. The minimum criteria required:

- *Ability to secure genuine people to sponsor disadvantaged children at Dr. Graham's Homes School*
- *Ability to raise funds for various GO projects*
- *A genuine interest in being part of a small but dedicated group focused on improving the lives of children and ensuring the longevity of Dr. Grahams Homes School*
- *Flexibility and commitment to attending discussions, meetings, and engaging in GO business and decision-making*
- *Given the diverse locations and time zones, available to attend a 2-hour zoom meeting once a month, minimum*

If you believe you possess the above skills, you are invited to nominate yourself. Your EOI must include the following details :

- Name/ Address/ Email Address /Mobile No.
- Year of exiting DGH; Cottage (if appropriate)
- Outline how your skills align with the above requirements and how they would benefit the GO Committee and, consequently, DGH
- Disclose any potential conflict of interest as a Committee Member (e.g. currently work at DGH; children attending DGH; a supplier of goods or services to DGH)
- Ensure you are a registered GO Member as at 31 July 2024.
